THIS FORM HELPS TO: - TRANSFER OWNERSHIP FROM THE SELLER TO THE BUYER - RECORD REASSIGNMENT OF A VEHICLE - PROVIDE PROOF OF TRANSFER FOR LEGAL AND REGISTRATION PURPOSES - ENSURE COMPLIANCE WITH CALIFORNIA VEHICLE LAWS LEGAL REQUIREMENT CALIFORNIA VEHICLE CODE MANDATES THAT THE TRANSFER OF A VEHICLE'S TITLE MUST BE DOCUMENTED PROPERLY. THE FORM IS REQUIRED IN SITUATIONS SUCH AS: - SELLING OR TRANSFERRING A VEHICLE - GIFTING A VEHICLE - TRANSFERRING OWNERSHIP DUE TO INHERITANCE OR ESTATE SETTLEMENT - REASSIGNING A VEHICLE'S TITLE AFTER A LIEN RELEASE OR OTHER LEGAL ACTIONS NOTE: IN SOME CASES, THE TRANSFER MAY BE COMPLETED ONLINE OR VIA OTHER DMV FORMS, BUT DMV REG 262 REMAINS A STANDARD PHYSICAL DOCUMENT FOR MANY TRANSFERS. --- HOW TO FILL OUT DMV REG 262 GATHER NECESSARY INFORMATION BEFORE COMPLETING THE FORM, ENSURE YOU HAVE THE FOLLOWING DETAILS: - VEHICLE IDENTIFICATION NUMBER (VIN) - LICENSE PLATE NUMBER - REGISTERED OWNER'S NAME AND ADDRESS - NEW OWNER'S NAME AND ADDRESS - SALE OR TRANSFER DATE - ODOMETER READING AT TRANSFER - PURCHASE PRICE OR FAIR MARKET VALUE (IF APPLICABLE) - SIGNATURES OF BOTH PARTIES STEP-BY-STEP COMPLETION 1. HEADER INFORMATION: - ENTER THE VEHICLE'S LICENSE PLATE NUMBER OR VEHICLE IDENTIFICATION NUMBER (VIN). - FILL IN THE DATE OF TRANSFER. 2. SELLER'S DETAILS: - PROVIDE THE FULL NAME AND ADDRESS OF THE CURRENT REGISTERED OWNER. 3. BUYER'S DETAILS: - WRITE THE FULL NAME AND ADDRESS OF THE NEW OWNER. 4. VEHICLE DETAILS: - INCLUDE THE MAKE, MODEL, YEAR, AND BODY TYPE. 5. ODOMETER READING: - RECORD THE MILEAGE AT THE TIME OF TRANSFER. 6. SALE INFORMATION: - STATE THE SALE PRICE OR SPECIFY IF IT'S A GIFT. 7. SIGNATURES: - BOTH THE SELLER AND THE BUYER MUST SIGN AND DATE THE FORM. 8. ADDITIONAL SECTIONS: - COMPLETE ANY OTHER APPLICABLE FIELDS, SUCH AS LIENHOLDER INFORMATION OR TRANSFER TYPE. NOTE: THE FORM MUST BE SIGNED IN THE PRESENCE OF A NOTARY OR DMV REPRESENTATIVE IF REQUIRED. ALWAYS USE ORIGINAL FORMS AND AVOID ALTERATIONS. --- SUBMITTING DMV REG 262 WHERE AND HOW TO SUBMIT ONCE COMPLETED, THE FORM CAN BE SUBMITTED: - IN PERSON AT A DMV OFFICE - BY MAIL TO THE ADDRESS SPECIFIED ON THE FORM OR DMV WEBSITE -

REGISTRATION STATUS AND FEES - REGISTRATION TYPE: STANDARD, TRANSFER, RENEWAL, OR SPECIAL REGISTRATION. - REGISTRATION FEES PAID: BREAKDOWN OF APPLICABLE FEES, INCLUDING REGISTRATION, TITLE, SMOG ABATEMENT, AND ANY APPLICABLE TAXES. - PAYMENT METHOD: CHECK, CREDIT CARD, CASH, OR ELECTRONIC TRANSFER DETAILS. 4. CERTIFICATION AND DECLARATION STATEMENTS - THE OWNER OR AUTHORIZED PERSON CERTIFIES THAT THE INFORMATION PROVIDED IS ACCURATE. - DECLARATION OF VEHICLE CONDITION, OWNERSHIP STATUS, OR COMPLIANCE WITH CALIFORNIA LAWS. - SIGNATURE AND DATE OF SIGNING. 5. ADDITIONAL SECTIONS (IF APPLICABLE) - LIENHOLDER OR FINANCE COMPANY DETAILS: IF THE VEHICLE IS FINANCED. - PREVIOUS REGISTRATION DETAILS: FOR TRANSFER OR RENEWAL PURPOSES. - SPECIAL NOTES OR CONDITIONS: ANY SPECIAL CIRCUMSTANCES, SUCH AS SALVAGE OR NON-OPERATION. --- CA DMV REG 262 7 HOW TO COMPLETE THE CA DMV REG 262 COMPLETING THE CA DMV REG 262 ACCURATELY IS CRUCIAL TO AVOID DELAYS OR LEGAL ISSUES.
